# Carlisle Trails Committee Report of September 11, 2009 Meeting Bert Willard, Secretary

### **New Trails Book:**

Most of the meeting was taken up with a lengthy discussion of the plans for a new and revised trails guidebook. At the July meeting the choices of trail guidebooks to emulate fell to the Bay Circuit Trail Guide, and the Acton Trail Guide. Steve Spang had volunteered to get cost estimates for both approaches and reported his findings as follows.

Steve obtained preliminary quotes from John MacKinnon Printing Co., Acton, for four different options. Each of the options has the same features: Heavy grade paper, off-white, 50 pages, Wire O-Bound, initial run of 1000 copies.
