# **Minutes from October 1 meeting:**

The minutes were approved as amended.

# Spencer Brook Boardwalk and Observation Platform:

Steve Hinton presented what he expected to be the final design for the boardwalk and observation platform on the Spencer Brook CCF property. Because of the tolerance in placing the helical piers, each piece of the boardwalk would have to be cut to fit on site.

Louise raised the question, could the 2x10x10 joists be placed on top of the stringers instead of securing them between the stringers with hangers? This would raise the boardwalk and platform 10 inches above that in the design presented. The benefits would be easier construction, since all pieces could be cut standard dimensions before being hauled to the site, and a much stronger structure. There was a discussion of how to feather the boardwalk to the ground since the piers could not be driven down another 10 inches.

It was agreed by committee members that this suggestion should be adopted during construction.

It was agreed that the materials should be hauled to the site after the ground freezes but before snow arrives.

The Trails Committee will do the framing before asking for volunteers to do the decking.

The developer has placed gravel so the Rangeway Trail can rise up to the Chestnut Lane roadway and ramp down on the other side. The developer has asked what we would like for a ground cover. No decision was made.
